Young Rhetoricians' Conference 2014	I/D	Amy	The description of the panel discussion was: "Tell Me Why": Test Measurement, Assessment, and Evaluation in Education— OR Dark Shadows: Assess the Assessors' Assessment Assessing the Assessed Why must instructors engage in test measurements beyond their own classrooms? Who presumes that instructors need SLOs to make meaningful, ongoing evaluation of effective methods of delivering material to students? Who benefits qualitative and qualitative data— the product of various assessment tools? This presentation invites a collaborative discussion of professionals' love/hate feelings towards SLOs and may answer many questions about the relevance of SLOs and the emphasis on assessment tools in education. Amy shared that the panel consisted of two people from Northern California and two from Southern California. The SLO representative from Southern California stated that there is a paid Division SLO coordinator who collects data from faculty within the division, assembles the data, and generates reports for each department within the division. Dialog on improving student learning based on the information within these reports takes place
			at the departmental level. SJSU has accomplished much in the area of student learning outcome process. Professor Harris is the lead and their materials
			are posted on the web.
