- Total resident and non-resident WSCH decreased 2% from 91,317 to 89,938.
- Total resident and non-resident enrollment decreased 4% from 20,298 to 19,529.
- Resident WSCH is down 3% from 81,006 to 78,287, and non-resident WSCH is up 13% from 10,311 to 11,651.

- First-time student headcount decreased 8% from 1,166 to 1,068 and FTES decreased 1%.
- First-time transfer student headcount decreased 17% from 2,319 to 1,915 while FTES decreased 13%.
- Returning student headcount decreased 5% from 1,605 to 1,530 and FTES decreased 2%.
- Continuing student headcount increased 1% from 7,256 to 7,339 and FTES increased 2%.

- Enrollment from San Jose Other, Santa Clara, Morgan Hill, Gilroy, and Campbell decreased 9% from 2,903 to 2,648.

### Zip Code Groupings by Ethnicity

- African American student headcount decreased the greatest in the San Jose East of 880, Alviso, Milpitas, Fremont, Union City, Newark, Hayward, and East Palo Alto area (15%). Followed by the San Jose Other area with a 12% decrease.
- Filipino headcount increased by 17% in the Cupertino, Sunnyvale, Los Altos, Mountain View, Palo Alto, Los Gatos, and Saratoga area and increased by 6% in the San Jose Other area. However, there was a 3% decrease in the San Jose East of 880 area.
- Latino/a headcount remained flat in the Cupertino, Sunnyvale, Los Altos, Mountain View, Palo Alto, Los Gatos, and Saratoga area and decreased by 1% in the San Jose East of 880, Alviso, Milpitas, Fremont, Union City, Newark, Hayward, and East Palo Alto area.
